



2. REGISTERED OFFICE

The Registered Office of the Trust shall be at NO: 3-C, Karthikeyan Road, Arni - 632 301, Thiruvannamalai District and or at such other place as the trustees may desire from time to time.

3. OBJECTS OF THE TRUST

a) To establish, to take over or acquire and maintain and manage schools, colleges and other educational institutions, hostels, orphanages, charitable organisations.

b) To award scholarships, stipends to students in India and enable their studies in India or in foreign countries and for purchasing books, to award prizes to students for proficiency in any subject or languages.

c) To promote study and research in any subject and afford facilities to those who conduct such study and research on any subject.

d) To give financial or corporal aid or other help to deserving persons.

e) To establish, take over or acquire and maintain and manage creches, homes for the old and disabled and orphanages and all such other lawful things incidental or conducive to the attainment of the above objects.

f) To impart training for advancement of knowledge in any subject or language.

g) To establish, maintain and manage hospitals, clinic, laboratories and Medical Research Centres and to provide the poor with medical aid.

h) To give subscriptions or donations to any charitable institution's.

i) To accept, upon such terms as they shall think fit, any donations, grants, subscription, aid and contributions from any Government, local authority, corporation, firm, company syndicate, association, one other person or from any charitable or other institution whether they be in cash or in other movable or immovable property for the purposes of the trust PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with or repugnant to the provisions contained in these presents and such donation, grants, aids, subscriptions and contributions shall be applied for all or any of the objects of the trust.

j) To acquire by purchase, lease or otherwise any property whether movable or immovable or any rights for the purposes of the trust and to sell, give on lease, mortgage or otherwise transfer any such property or rights.

k) To construct, maintain or alter any building or works necessary for the purpose of the trust.

l) To take up the socio-economic programme for the betterment of women and children.

- m) To take up any Rural Development conduct the same.
- n) To receive grants from any agencies including Central Board for the workers Education and to conduct programme for them.
- o) To do such activity \ activities for furtherance of Art, Literature, Music etc.
- p) To spread knowledge and education by publication of books, periodicals, journals, literature etc.,
- q) To construct new wells and maintain and repair existing wells, tanks and other sources of water for the benefit of the public and to give monetary help for the same.
- r) To give monetary aid or other help for relief from natural calamities like floods, cyclone, tempest or otherwise, to give monetary aid or other help for the disposal of dead persons or cremation or performance of obsequies.
- s) To give aid for the promotion of agriculture, horticulture and the like and for research in the same subjects.
- t) To assist renovation of places of historic, archaeological or artistic importance.
- u) To do all such other lawful things as may be considered incidental or conducive to the attainment of the objects mentioned above.

4. INVESTMENTS

All monies which shall not immediately be required for current expenses shall be invested by the Trustees in investments and securities authorised by law according to the provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act 1961 or other relevant provisions of law for the time being in force and shall be in the name of Trust only.

5. TRUST FUND

The Author of the Trust declares that the sum of Rs. 1,008/- (Rupees One Thousand and Eight only) that has been dedicated by him for public charitable purposes and objects of general public utility described above, the receipt of which the TRUSTEES have acknowledged and that the TRUSTEES shall and will stand possessed of the said sum of Rs. 1,008/- (Rupees One Thousand and Eight only) WPAAN Trust and also any other properties, movable or immovable, which the Trustees may from time to time receive for augmenting the Trust Fund or for specified purposes connected with the objects of the trust not calculated the impede the due working of the Trust arising from donations, bequests, gifts, legacies or grants in cash or kind or from any other source whatsoever and also of any investments for the time being representing the same (hereinafter called the Trust Fund) and also of the net income from the Trust Fund into Trust, and to apply both the income and the capital of the Trust Fund for the purposes of the Trust.





b) The Board of Trustees shall consist of not less than 7 and not more than 12.

c) The Trustees shall be trustees for their life time.

c) The number of Trustees may be altered according to the decision of the Board of Trustees subject to (b) supra.

d) The Trustees shall hold such office as Trustee during their life time unless they should vacate the office earlier for any reason whatsoever. In the event of there being a vacancy in the office of such trustees, it shall be filled up by co-option by remaining trustees. In the event of a Trustee retiring on his/her own, the person nominated by him/her on his/her behalf shall take the place of such retiring person if the remaining Trustees co-opt for the same.

7. POWERS OF THE BOARD:

A) The Board of Trustees shall have all powers necessary or incidental for effectually carrying out the objects of the trust.

B) Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred by the other provisions contained in THESE PRESENTS, the Board of Trustees shall have the following powers also:

a) To apply the trust moneys to effectuate one object or some of the objects of the trust in preference of the other objects.

b) To discontinue the application of the Trust funds to one object and divert the funds to another object.

c) To determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by Trust.

d) To extend the funds of the Trust in such manner as they shall consider most benefical for the purposes of the Trust.

e) To acquire, build upon pull down, re-build, and to alter, repair, improve, sell or dispose off or otherwise deal with any land, building or premises or property for the use of the Trust. .PA

f) To take any property on lease or hire.

g) To acquire any Property.

h) To enter into any contracts on behalf of the Trust.

i) To borrow any money upon the security of any property of the Trust, sign promissory notes, bills of exchange, hundies or any other financial documents and to grant mortgages for securing the same or without any security and upon such terms and conditions that the trustees may deem fit.

j) The Trustees shall have power to collect rent, interest or other income and invest the Trust Fund and vary such investments from time to time and sell or realise the investment for the purposes of the Trust. The Trustees shall have powers to mortgage, raise loans or encumber, sell or lease out or otherwise alienate the immovable properties, if any of the trust: unless and until necessity or occasion compels such a sale, transfer or encumbrance or other alienation of the immovable properties. In any such event, the Managing Trustee shall be competent to sell, lease, encumber or otherwise alienate the properties of the trust, after due authorisation by the Board of Trustees.

k) To lend or invest the surplus funds of the Trust in such manner as may be decided by the Board of Trustees.

l) To incur all such expenses as are necessary for the execution of the Trust and powers under these presents.

m) To raise donations or accept gifts or contributions in cash or in kind.

n) To appoint auditors to audit the accounts of the Trust.

o) To appoint legal advisers for the Trust.

p) To reimburse the Trustees towards the pocket expenses which may be incurred by them in the course of, or in relation to the affairs of the Trust.

q) To receive donations, contributions, gifts, bequests, legacies and endowments from individuals, charitable or other trust or institution for the objects of the trust on such terms and conditions as may be accepted by the trustees.

r) To make, alter, rescind any rules or regulations in regard to the conduct of affairs in respect of which any power or duty is vested in them for the convenient and effective management and administration of the Trust.

s) To make and from time to time repeal or alter the regulations:

i) as to the details of management of the trust and the affairs thereof;

ii) as to the duties of any officers or servants of the trust.

iii) as to the conduct or any of the matters or things within the powers or under the control of the Board provided that the same shall not be inconsistent with the provisions contained in these presents.

t) To settle out of the court, compromise or compound all suits, actions, and other proceedings and all differences or demands and to refer all or any of such differences or and approve all accounts without being answerable for any loss occasioned thereby.

m) To appoint and dismiss managers, secretaries, clerks and other staffs and at their discretion remove, dismiss or temporary or special service in connection with the work of the Trust, Trust estate, Trust fund and Trust properties as they may from time to time think fit and to determine their powers and duties and fix their salaries, bonus or emoluments and to require security in such instance and such amounts as the Trustees may think fit. The Trustees shall also have power to found and maintain, Provident funds, Gratuity funds, personals and other funds for any employees and make rules and regulations regarding the same.

B. POWERS OF THE MANAGING TRUSTEE:

In the event where the board of trustees have any tie, the Managing Trustee shall have the powers of the Board as mentioned in Clause 7 supra.

9. CUSTODY OF DOCUMENT:

The Managing Trustee for the time being shall have the custody of all deeds and documents of title relating of Trust Properties and investments and the books of account and other records relating to the trust and shall be responsible for the same and their safe custody.

10. BANK ACCOUNT:

All income, subscriptions and pecuniary donations for the general purpose of the trust and the income of investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received to be paid into a bank account or accounts with any scheduled bank or banks which the board may determine. Such Bank Accounts may be operated Individually by the Chairman or Secretary or Reasurer.

11. ACCOUNTS AND AUDIT

a) The Managing Trustee and the Treasurer shall keep proper accounts of the income and expenditure of the Trust, shall prepare a financial statement and Balance Sheet for every year as on the last date of 31st March and signed by the Managing Trustee and the Treasurer.

b) The accounts shall be got audited by a Chartered Accountant appinted by the trust for this purpose and who shall not be a member in board ;

12. TERMS OF OFFICE OF THE TRUSTEES:

The First Trustees of the Trust shall hold office for life or until they resign. R.RAVICHANDRAN shall be the Chairman and M.VIJAYAKUMAR shall be the Treasurer of the Trust. The Office bearers of the trust shall hold office for a period of 3 years from the date of appointment and thereafter any person among the Board of Trustees shall be elected to the office of Chairman, Treasurer and Secretary respectively. The retiring trustees from office are eligible to seek re-election.



13. POWERS TO CO-OPT:

The Trustees shall have the power to co-opt additional Trustees or to fill up any existing vacancy in the Board of Trustees however, that the total number of Trustees shall not be in law or exceed the number fixed in 6(b) supra.

14. VACANCIES OCCURRING IN THE OFFICE OF THE TRUSTEES:

The vacancies occurring in the office of the Trustees shall be filled by the remaining Trustees within 3 months of the arising of such vacancies. If there are no Trustees, functioning of at any point of time, the TRUSTEES shall be appointed in accordance with the law by a Court of competent jurisdiction. Where at any time the number of TRUSTEES fall below the minimum prescribed in clause 6(b) supra, the continuing TRUSTEES shall have the power to Co-opt any person or persons to fill up such vacancy.

15. VACANCY NOT TO INVALIDATE THE PROCEEDING:

Any vacancy in the Board of Trustees and/or any illegality in the appointment of TRUSTEES or their proceedings shall not invalidate any prior act or decision of the Board of Trustees.

16. ADMINISTRATION:

The Board of Trustees shall have full power and authority to administer the trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfil the performances for which the TRUST is established. The Board of Trustees shall act through the Managing Trustee.

17. APPOINTMENT OF MANAGING TRUSTEE:

The First Managing Trustee shall be R.RAVICHANDRAN who shall hold office for a period of 3 years stated in clause 12 supra.

The Managing Trustee shall have all the powers vested in the Board of Trustees and shall act on behalf of the Board of Trustees subject to the over all control and Superintendence of the Board of Trustees.

18. PROCEEDINGS OF THE TRUSTEES:

The Board of Trustees may meet as often as may be necessary for the efficient conduct of the Trust. The TRUSTEES may take decisions on any matter either at their meetings or by circulation of resolutions on papers.

19. QUORUM:

The minimum number of TRUSTEES to be present for conducting a Meeting of the Board of Trustees shall be 4 or 50% of the total number of Trustees whichever is more.

20. VOTING:

Each Trustee shall have one vote. The opinion of the majority of the Board of Trustees present at a Meeting shall be final in respect of all matters relating to the Trust.

21. MINUTES, ACCOUNTS AND AUDIT:

The Trustees shall maintain true and correct account of the Trust and a correct record of their deliberations and get the accounts duly audited by a Chartered Accountant.

22. NET INCOME OF THE TRUST:

The Trustees shall invest and recover the income of the Trust Fund and shall provide for all costs, charges, incidental expenses including Insurance premium expenses, ordinary repairs, etc., and all other outgoing and expenses for the management and administration of the Trust.

23. CREATION OF RESERVES:

The Trustees shall set apart and credit to the depreciation, sinking or other fund, such percentage of, or portion, or whole of the income of the Trust Fund as may from time to time be determined by the Trustees. However, as and when the balance standing to the credit of such fund exceeds the minimum amount which, the Trustees may from time to time consider sufficient, it shall be lawful for the Trustees to transfer such surplus amount to the General Trust Fund and apply it in the same manner as the Net Income or the Trust Fund.

24. APPLICATION OF INCOME AND TRUST FUND:

The Trustees shall, after providing for the aforesaid payments and disbursements and after setting apart any sum for Sinking Fund, Reserves, etc., apply and utilise the Net Income or the Corpus of the Trust, or the Trust Fund for the fulfilment of all or any of the public charitable purposes or objects of general public utility referred to in para 3 supra by such ways and means as the Trustees may from time to time in their absolute and unfettered discretion determine.

25. TRUSTEES AND THEIR RELATIVES NOT TO BENEFIT:

Notwithstanding the power vested with the Trustees under the proceeding clauses, no part of the income of the Trust shall ensue directly or indirectly and no part of the income or property of the Trust shall be used or applied directly or indirectly, for the benefit of the Trustees or any person who makes a substantial contribution to the Trust or any relative of the Trustees or the person who makes a substantial contribution.

26. LIABILITY OF TRUSTEE OR TRUSTEES:

In the professed execution of the Trust and powers conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent or employee employed by him or by any other Trustee hereof although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the Trustees or by reason of any other matter or thing except wilful or deliberate fraud on the part of the Trustees, who alone may be subject to be made so liable.

GENERAL:

27. The Trust is irrevocable.
28. The Trust hereby constituted fails for any reason, the net assets of the trust shall be made over to any public Charitable Trust having objects similar to this Trust.
29. The income and fund of the trust will be solely towards the objects and no portion of it will be used for payments to the Trustees by way of profit.

31. Any amendment to the trust deed will be carried out only with the approval of the Director of Income Tax (Exemptions) Chennai - 34.
32. No activities of the trust will be carried out anywhere outside India.
33. The trust will not carry on any activity with the object of earning a profit.
34. The seal of trust shall bear the inscription " SRI MAALAIAMMAN EDUCATIONAL TRUST " and shall remain in the custody of control of the Managing trustee.
35. The Trustees shall be entitled to be indemnified by the Trust properties against the consequences of all lawful acts done by the Trustees in the course of and discharge of their duties as Trustees of the Trust and all costs, charges and expenses thereof.


